If elected, I would consider how decisions being made affect students with differing interests and differing ability levels. It is also important to consider how decisions contribute to school climate. I believe the board has an important role in setting the tone in this respect.	I think there are a lot of things that allow a district to meet the needs of different learners. To begin with, one needs to acknowledge that each child's experience is unique and that the district's job is to provide each individual with the opportunities to get them to their own next best place. For some students, that will involve using a variety of teaching styles to get content across. Strong Professional Development is crucial for teachers to keep their teaching fresh, energized and current. For some students it will be a broader variety of classes, whether made available in ORCSD classrooms, on-line, at the University or some other venue. For still others it will require making sure that our learners continue to get the additional supports and small class sizes that they need to be successful and connected.	I will focus on the <u>working together</u> part of the slogan. I firmly believe that every major decision must be made after a clear process of determining our needs and getting input and thoughtful analysis from all groups that will be affected. I will champion working together for good decision making processes.

7. Our district has seen a number of talented and valuable employees leave the district in the last few years. What will you do to attract and retain exceptional talent to the Oyster River District?

Oyster River has traditionally had a reputation of being very supportive of educators, and I believe that is true. I think the recently negotiated teacher contract is an example of this. Oyster River has also traditionally supported teacher creativity in the classroom. With the implementation of the Common Core, I think a real challenge will be to continue to allow teachers the freedom to be creative and use their strengths.	Quality educators are attracted to and stay in districts that value them as professionals. This means once the district has agreed that they are aligned with our philosophy of education, we must trust them and listen to them. I do not mean that we follow them blindly but rather we listen, ask questions, give feedback, discuss and then trust they are going to do what is in the best interests of our students and our community. Providing a stable environment in which to work is attractive. Providing mentors to new teachers is key. Lastly the board must work with the leadership team to prioritize and stay focused.	I want to ensure than employees feel heard in the district, that teachers and staff are included along with students, parents and the community in providing input for planning and decision-making. We have an incredibly committed team of teachers, staff, and administrators. It is important that they all know that the school board and community support and respect our district's employees at all levels. I believe we can increase the sense of community and ownership among all Oyster River employees that keeps teachers, staff, and administrators wanting to come to and stay in the Oyster River schools by including all employee groups in figuring out where we need to focus our energy.

8. What will you do to ensure the opinions of the entire community are heard and listened to?

9. What steps are you prepared to take to encourage transparency by the Oyster River school board?

Transparency is very important and I will take great care to abide by the laws governing school board discussions.	It is important that there be good communication between the schools and the community at large. I will see that I am knowledgeable and current with all RTK laws. I will vote for policies that promote transparency and I will keep board conversations at the board table.	I would like to see more cases where a detailed proposal is presented to the community before the meeting where the board will be acting on it. In 2013, the discussions around high school tuition agreements were a good example of how this should be done; the process of resolving elementary enrollment was not. I expect that the decisions the board makes should have thoughtful analysis before the board acts. This is where my engineering and project management experience will be useful. The board should not make major decisions without a detailed proposal being available for public review and comment, for example being proposed at one meeting and voted on at the next.

10. What do you see as the role of school board in our community? Will you adhere to guidelines set up by the New Hampshire School Boards Association that address such a role?

The primary responsibilities of the board include setting policy and creating a district budget to be presented to the voters. It's important for school board members not to overstep their bounds. I believe remaining mindful of this at all times is key. I also believe that I need to be a visible advocate for public education because it is one of the community's most important assets. Promoting it publicly allows people to feel proud and invested in the district's continued development. I will absolutely adhere to guidelines set up by the NH School Board Association.	The school board's job is to represent the community to make sure we have the right people, priorities, and policies. The NHSBA guidelines are clear and I agree with them. It's the board's job to find and keep excellent administrators, and ensure that the environment in the district is right to find and retain excellent teachers and staff. The board represents the community in setting priorities and maintaining financial oversight. We have a thoughtful community that deserves a thoughtful and deliberate school board.

11. What specifically will you do to ensure the school board meetings are run in an efficient and productive manner?

That being said, it is important to devote the time needed to discuss all aspects of an issue to arrive at the best decision for our district. I will communicate in a respectful and productive way, listening and learning from administrators, staff members and community members. When asked to make tough decisions, I will do so with the interests of all ORCSD students and community members in mind.	Part of the job of the school board is to thoroughly consider what a decision will mean to all affected. Sometimes this means that school board meetings need to be long to be productive. I will push for a clear set of priorities that should help make decision making clear and more efficient. As an engineer, I am used to providing and getting detailed plans and detailed analysis, and I would not hesitate to ask at a board meeting for a proposal to be developed or analyzed in greater detail before it is presented rather than spend a lot of time discussing different interpretations of the proposal.
